| 3 | The children of the deceased who do not meet the requirements of Art. 20 of the Occupational Pensions Act (BVG/OPA). | If numbers 1 and 2 do not apply, the order of numbers 3 to 5 can be chosen freely. |
| 4 | The parents. | |
| 5 | The siblings. | |
| 6 | The other legal heirs, to the exclusion of the community. | |
